Planning and Zoning- Crockett

- Ordinance 13-27, authorizing a special use permit to allow the construction and operation of a gas station to be located at 11 South Marquette Place, Manteno, IL. This will possibly be a Casey's gas station. (B-#4)
- Ordinance 13-28, rezoning a part of Lots 1 and 2 of South Creek Subdivision, Sixth Addition, from a C-2 Commercial District to I-1 Light Industrial District. On January 14 there was a public hearing and testimony was heard about the zoning change. Jacob Carlile from Voortman made a presentation to the Board about the rezoning of South Creek. The expectation is for one semi-truck a month and most of the truck traffic will be UPS. There won't be any loud or noisy manufacturing. Voortman is not asking for any new tax incentive or benefits and hope to expand with 15-20 new jobs in the future. (B-#5)
- Ordinance 13-29, Amending the Manteno Zoning Ordinance by providing for the Regulation of Medical Cannabis Facilities. This ordinance is just allowing the Village to regulate the zoning. The state puts limitations for the distribution and cultivation. Nothing in the ordinance would prevent from coming. (B-#6)
- At the last Planning and Zoning Committee on January 16, 2014 they discussed updated permit card with stickers for inspections that would help contractors and the Title 9 Zoning of side lot lines.
