Consideration RE: A motion to authorize the Village President to sign the renewal of the
Lease Agreement between the Village of Manteno and MYBSL (Manteno Youth
Baseball/Softball League). Every year the Board and the local baseball/softball
organization enter into an agreement to allow the use of the fields and concession stand
at Heritage Park. The Agreement allows for the mutual benefit of the community, by
having a place for the program to continue providing an organized recreational baseball
and softball program for the children. The Board recognizes the volunteer effort this
program requires and is grateful for all their hard work.

- Ordinance 20-26: An Ordinance authorizing the Sale of Personal Property (Surplus Municipal Equipment). The Police Department has a 2007 Nissan car that is no longer useful to the department. This is a vehicle that was seized several years ago and used for transportation to and from training events.
- Consideration RE: A motion to authorize the purchase of four (4) 2021 Ford Police Interceptors at a cost of \$34,135.00 each from Taylor Ford of Manteno. (This is a state bid price) As discussed at the recent Finance Meeting, we will be paying for two vehicles in this fiscal year and the other two in FY 2022. Although we did not budget for two vehicles this fiscal year, revenues have come in higher than expected and the Board felt replacing outdated police vehicles is a priority for maintaining resident's safety.
- Consideration RE: A motion to authorize the purchase of a fixed LPR camera system from Minuteman Security Technologies, Tinley Park, IL for a cost of \$27,815.29. This authorizes the updating of our camera system at the I-57 interchange to improve the license plate reader system and repurpose the existing camera's to use for overview coverage. The cameras have been instrumental in solving many crimes, including a recent accident that damaged the traffic light control box at the west intersection. The offender fled, but was identified by the camera system and charged, ensuring the costly repairs will not have to be paid by the Village. This system update is a budgeted expense.
- Safety tips Watch out for slick roads with the warmer weather, as ice will melt during the day, then freeze up at night and early morning.
- We need to help clean out the snow around the fire hydrants. The Village has been cleaning out as many as possible around the Village, but if you see a neighbor who needs help in digging out around their fire hydrant, please help out.
- Scott's Law This is the law in which you need to move over safely a lane of traffic if
  there is a disabled vehicle by the side of the road or if there are flashing emergency
  lights of an authorized emergency vehicle. Slow down and be aware.
