## **Items for Discussion:**

- Significant Incidents
  - Chief Swinford provided a summary for the January/February significant incidents
    - Burglary to poker machine at the Sportsman's Club A group of individuals is going through
      the area and other municipalities. A car has been identified with an Indiana plate.
    - Dog rescue at Manteno Lake two officers and local residents helped the dog to shore. Body cam video was shown on Chicago ABC channel 7.
    - Leadership training was supplied to supervisors
    - Verizon provides the service lines for data lines for vehicles. It was determined that the department was being billed for unused lines or devices. It has taken a year to get the issue resolved. A credit of \$5,000 \$6,000 will be received.
    - Had several officers who participated in the Special Olympics Polar Plunge it was different than in past years due to COVID.
    - New hire list has been created had 56 applicants.
- Monthly Stats Chief Swinford provided stats for the months of January/February on incidents, reports, cases, etc.

- **875 Marble Blvd.** Chief Swinford stated that Lt. Lockwood and Mr. Marion will be testifying on Thursday concerning the case.
- Auto-theft Detail/Grant Chief Swinford was approached by the Stolen Auto Task Force about a grant that would be available to have an officer from Manteno to join the task force. It is a full-time grant that would cover 100% of salary; does not include benefits or overtime. This is an on-going grant with no time limits. Chief Swinford provided a potential cost of benefits that the village would be responsible for. Chief Swinford will continue to investigate the possibility of the grant and come back to the committee with details.
