#### **NEW BUSINESS:**

- **1. Planning Commission Recommendation 19-04 on the requested special use permit by National Bank of St Anne.** National Bank of St Anne (Owner) is requesting the required Special Use Permit to install a three (3) lane drive-thru and external ATM for the use of its banking customers. The new branch bank is being constructed at the old Family Video property ,102 South Creek Dr. Current ordinance requires a special use permit for any and all drive-in or drive thru. After conducting the public hearing on the variances requested, the Planning Commission will be asked to make a recommendation to the Village Board.
