- Ordinance 21-22: An Ordinance amending Title 4, Police Regulations, Chapter 1, Article 6, Offenses Involving Morality, Section 4-1-6-12, Gambling, of the Municipal Code for the Village of Manteno. As discussed at a previous Finance Committee Meeting, the State amended the gaming statute to allow non-home rule municipalities to increase the fees associated with gaming terminals. This will increase the fee from \$20.00 per terminal to \$250.00
