- **Rt. 50 Development and Improvements** Trustee Crockett would like to discuss ideas on adding beautification along Rt. 50 that would tie into the areas we have completed on Division Street and Main Street. Mayor Nugent stated that Rt. 50 may be harder to work on due to it being a State Highway. Mr. Hanley suggested updating the entrance signs into the village. Mr. LaRocque suggested using the stone pillar look with back lighting and use the arch look to tie into the Main Street area. Mr. Hanley will speak to Hitchcock about a design. Mayor Nugent would like to see if other communities have been given permission from the state for beautification projects along state highways.
