### • KAMEG Officer Discussion

The narcotics task force for Kankakee County area has obtained a federal grant for \$25,000 to cover a portion of an officer's salary and \$7,000 for overtime. Chief Swinford would like to move forward with this and place one of our officers on the task force. The village's portion would be approximately \$70,000. There is no end date for the grant. The committee is in support of the idea to start in January 2025.

## • Firing Range Discussion –

Chief Swinford was asked by our firearm instructors if an area behind the new Public Works building could be used as a firing range. Currently the department uses a firing range in Peotone. No equipment can be stored there and on duty officers cannot use it since it is out of town. The design needs to be safe for all surrounding properties. Dirt could be moved from any village project, and we could accept dirt from contractors to build the berm. Trustee Gesky suggested the department look at Exline Sportsman's Club for ideas and Trustee Boyce also suggested looking at Elwood.

## • Personnel Update –

### • Radio Update -

Radios will be programmed by KanCom. The old radios will be declared surplus.
