# **Public Works – Trustee Boyce**

- Resolution 21-24 A Resolution approving a Professional Services Agreement with Novotny
  Engineering in connection with providing Professional Engineering services for the South Creek
  Drive Shared Use Path Project. The Village wants to connect the north and south paths by
  installing a connecting path on South Creek Drive between Division and Cook Streets. This will
  begin that process by facilitating the needed engineering.
- Resolution 21-25 A Resolution approving a Professional Services Agreement with Novotny
  Engineering in connection with providing Professional Engineering Services for the Main Street
  Beautification Project. This is the next step to begin the engineering process for the Main
  Street renovation. Novotny Engineering has also submitted a grant application on behalf of the
  Village for this project. That grant should be awarded sometime in April.
- Resolution 21-26 A Resolution approving a Professional Services Agreement with Novotny
  Engineering in connection with providing Professional Engineering Services for the New Public

- Works Facility Project. As the new public works facility process continues, we need to begin the engineering for the site to prepare for the new building.
- Consideration RE: A motion to award the bid for Bid Package 1 of the new Public Works Facility project to J&A Mitchell Steel Fabricators for the cost of \$1,589,500. Carlisle Architects solicited bids for the main steel building portion of the new public works facility. We received 8 bids and J&A Mitchell was the lowest qualified bidder. The building is not expected to arrive until August due to supply chain issues.
- Consideration RE: A motion to award the contract for the Legacy Park Concession Stand Electrical to KPI Electric, Kankakee, IL for the cost of \$62,560.00. The Village solicited bids for the electrical portion of the concession stand project in Legacy Park. KPI was the only bidder and is qualified to do the work.
- Consideration RE: A motion to award the contract for the Legacy Park Concession Stand HVAC to G. Heating & Air Conditioning, Inc., Manteno, IL, for the cost of \$22,185.00. The Village solicited bids for the HVAC system for the concession stand project in Legacy Park. G Heating was the lowest qualified bidder.
