- ✓ A COPY of current valid Illinois driver's licenses or state ID cards for **ALL NAMES** shown on the tax bill. The address on the ID(s) must match the property being applied for.

*(Originals will not be accepted; no copies will be made by the village; additional documentation may be required at the village's discretion and may include trust agreements; marriage licenses; death certificates, etc.)*
