• **Consideration RE:** A motion to award the bid for the New Public Works Facility Bid Package #3 Site Work to Tenco Excavating, Inc. for a cost of \$1,897,556.90. Jim Hanley explained that on April 14th, the Village had a bid opening for the site work to be done at the new public works site. We received three bids, and Tenco Excavating was the lowest qualified bidder.

Each year the Village and the baseball/softball program enter into a lease agreement for the use of the fields at Heritage Park. The Village appreciates the hard work the program provides for the maintenance of the fields and the opportunity they provide for the youth of our community.

Public Safety and Health- Trustee Dole

- Ordinance 22-03 An Ordinance amending Title 3, Business Regulations, by adding Chapter 23, Hotel Establishments, of the Municipal Code for the Village of Manteno. As discussed at several recent committee meetings, the Board felt it necessary to draft and adopt this ordinance to ensure hotel rooms are used for their intended purpose of primarily short-term stays. Extended stays are only allowed under specific circumstances. Mr. Marion and Mr. LaRocque will schedule meetings with the two hotel owners to explain the new ordinance and its intent.
- **Consideration RE:** A motion to authorize the purchase of security camera systems at Legacy Park for a cost of \$11,583.00 and at Dunkin Donuts and Manteno Foot & Ankle Clinic for a cost of \$4,515.00 from Cinema Home Solutions, St. Anne, IL. With the approval of this motion, the Village continues its expansion of security cameras. These two new systems will provide video coverage in critical areas that were previously lacking. The Manteno Police Department relies heavily on video surveillance to help solve and deter crimes.

- Ordinance 22-01 An Ordinance Amending the Manteno Zoning Ordinance by Changing Regulations Applicable to Planned Unit Developments and Siting the Same within Specific Zoning Districts. This modification brings the PUD ordinance up to date and streamlines the process to better reflect recent changes to current developments.

As with the PUD ordinance, the Subdivision Ordinance also needed updating. One of the goals with these two ordinance amendments was to make the process and requirements as similar as possible since both are the major ways to develop vacant land into subdivisions.
