Trustee Dole called the meeting to order at 7:34 a.m.

A motion was made by Mayor Nugent, seconded by Trustee Boyce, to approve the minutes of the May 11, 2022 as presented; motion carried by voice vote. All ayes, no nays.

No Public Participation

Items for Discussion:

- **Significant Case Update** –
 - There were six car burglaries reported last week. The offenders were driving a stolen vehicle out of Manhattan. The crew also hit the Village of Bourbonnais. All cars were unlocked.
 - Reported incidents at the Jumping pillows has slowed down. There were very few reports over the last few weeks.
- **Monthly Stats** – Chief Swinford presented the monthly stats for May 2022. (*see attached*).
- **Personnel Update** – Officer Ritter submitted his resignation effective 6/28/22. The process for the replacement has been started. The academy has extended the length of the training to 16 weeks. The hiring list expires in December.
- **PD Facility Update** – The bank has started the process of moving out. Staff has met with Carlile Architects about the remodel. The first draft of the remodel is expected in the next week or so. The award of the bid for the project is hoped to be approved at the September 19th board meeting with a start date of October 1st.

Mayor Nugent would like to start discussions on what the village will do with the current facility after the Police Department moves to the new location.

- **Damage/Vandalism Recap** - Mr. LaRocque stated that two of the damage claims by vehicles have been paid by their respective insurance companies. The other damage claim to a tree was being paid by installments by the offender. He was killed in an auto accident. He had paid approximately half of the bill. There have been no other items added to the list. Chief Swinford stated that there was some graffiti at the River Valley Bus Station; their personnel cleaned it up quickly. River Valley Metro Police are investigating the incident.

A motion by Mayor Nugent and seconded by Trustee Dole to adjourn the meeting at 7:41 a.m. Voice vote – all ayes.
