• Ordinance 22-06: An Ordinance approving a Re-subdivision plat on property located at 2803 West Division Street in Manteno, Illinois in the C-2 Commercial Zoning District. The Planning commission held a meeting on June 14<sup>th</sup>, 2022, to consider a simple re-subdivision to create a separate, buildable lot north of the new Dunkin Donuts site. Due to the original size of the lot and the amount of land remaining after construction of the new business, the developer had enough land remaining to create the second buildable lot. This re-subdivision will allow for further development and the new lot meets all our zoning requirements. The Planning Commission is recommending approval of the re-subdivision request.
