Items for Discussion:

• Significant Case Update –

- There was a fire at 94 Norway. No injuries were reported. The fire started in an abandoned trailer and then spread to several adjacent homes. Chief Swinford praised Manteno Fire for their quick response. The fire is still being investigated.
- Monthly Stats Chief Swinford presented the monthly stats for June 2022. (see attached).

• Personnel Update –

- o Officer Lengel is now working with the Stolen Auto Task Force
- Officer Ritter left our employment to work with the state.
- The department is down two officers. The background on Kyle Schubert has been completed. A conditional offer of employment may be coming soon. Background investigation has started on the next person on the list. The department is on the academy waiting list for three spots for classes in September.
- o The Police Commission is working with Standards and Association for the next testing cycle.
- Chief Swinford stated that there are five officers who could retiree. Sgt. Gagnon is the only one that has indicated that he will be retiring at the end of the year.

- The School District has interest in a second school resource officer. Chief Swinford would like to hold off at this time. The village is supportive of the program, but the timing doesn't work for the department. It will be reevaluated next year.
- **PD Facility Update** Staff will be having a third meeting with Carlile on the design on July 24th. Mayor Nugent would like to have a sign erected stating "Future Home of Manteno Police Department".
- Golf Cart Registration Update There are 508 registered golf carts in the village, with just 45 old registrations that have not renewed.

Trustee Crockett exited the meeting at 7:45 a.m.

• **Damage/Vandalism Recap** - Mr. LaRocque presented the updated damage/vandalism spreadsheet. (see attached). There were no problems during the fireworks.

Mayor Nugent stated that negotiations will be starting soon with the garbage company. Our contract expires in 2023.
