As discussed at the Public Safety Committee meeting last week, the FOP has requested a change in language regarding holiday pay. As written, personnel could take pay or compensation hours for holiday pay, which in turn made that pay non-pensionable. By eliminating the option of comp time, all holiday pay will now be compensated in that pay period and will make those payroll expenditures pensionable for the rank and file.
