October 2017 Manteno Police Pension Board Meeting (10/18/2017)

Joe Grant called the meeting called to order at 4:13pm on October 18, 2017, at Manteno Village Hall

Joe Grant moved to accept the minutes of the July 2017 meeting of the Manteno Police Pension Board. Mike Berns seconded.

Joe Grant welcomed guests – Sheila Martin (Treasurer), Anthony Brown (Rockwood Capital), and John Rebus. Joe Grant ask for public comment, and no public comment was offered.

Sheila Martin provided the treasurer's report. Bills were read.

Aaron Tobeck – \$1,231.08 for conference reimbursement Mike Berns – \$1,192.51 for conference reimbursement Bill Cushman - \$1,274.48 for conference reimbursement Reimer, Dobrovolny, & Karlson LLC - \$6,636.87 for legal services June-August TCG Public Consulting Ltd. - \$4000.00 for actuarial evaluation IPPFA 2018 membership dues - \$795.00

The checking account was reviewed. The balance was \$471,750.39 on 9/30/2017. Sheila Martin provided a report of property tax distributions (see attachments), and indicated that the Pension Board has received three property tax distributions since the July 2017 meeting. This brings the total distributions to four for the calendar year.

Bill Cushman made a motion to move \$371,750.00 from the checking account into investments. Mike Berns seconded.

Anthony Brown from Rockwood Capital Advisors, LLC. reported on investments. Anthony Brown provided a portfolio summary for 3rd Quarter. Beginning market value was \$5,338,197 and the ending market value was \$5,509,450. 3rd Quarter total fund return was 3.1% which is a total dollar change of positive \$171,253. A question was asked about the annuities holdings. The recommendation from Rockwood Capital is to liquidate the annuities identified in Exhibit II of the 3rd quarter investment report because the investments are not appropriate for a police pension fund. Anthony Brown asked Joe Grant if he had received any response from letters sent to John Hancock (August 21st, 2017), Principal Life Insurance (August 10, 2017), and Raymond James (September 20th, 2017) instructing them to liquidate the John Hancock annuity (contract #FX06015505) and Principal Life Insurance Co. (contract #8861769). Joe has not heard response.

Joe Grant moved to send additional letters to the Principal Life Insurance Co., John Hancock, and Raymond James to authorize Rockwood Capital to liquidate these two accounts (FX06015505 and 8861769). Mike Berns seconded.

Joe Grant asked for any miscellaneous communication – none Board officers report – None

Old Business – Joe Grant asked for discussion of the IPPFA conferences. General sense is that the conference was not as engaging as it has been in previous years. Next year's conference is scheduled from October 2nd – October 5th of 2018 in Lake Geneva, WI.

Attorney's Report – Brian Labardi joined the meeting from telephone. Joe Grant asked for Brian Labardi to comment on execution of the municipal compliance report. Brian Labardi indicated that this is a statutory requirement. The report was reviewed. Mike Berns moved to execute the municipal compliance report. Bill Cushman seconded.
