Trustee Gesky called the meeting to order at 7:25 a.m.

## **Items for Discussion:**

- **Property Tax Rebate Update** The village has received 350 applications as of yesterday.
- **Camera Rebate Update** The village has received 10 applications for this program.
- **Project Cost Recaps** Mr. LaRocque provided cost recaps for Police Department Remodel; Public Works Facility; Legacy Park Concession Stand; Thies Park Improvements and Walnut Street Decorative Lighting project. (*See packet*)
- Month End Financial Report Mr. LaRocque stated that the village is one-quarter through the current fiscal year. All departments are doing well. Property Tax revenue first installment has been received. Revenue from sales tax and gaming tax is slightly higher than last year. Interest revenues will be up significantly compared to last year. Another round of renewals of CD's will come in September.
- Misc:
  - Mayor Nugent updated the committee about the Project Unity Intergovernmental Agreement that the Village Board approved on August 7<sup>th</sup>. The Manteno Fire Protection District and the Manteno/Rockville Township Assessor have both approved the agreement. The Manteno Township and the Manteno Township Road Commissioner are meeting today to discuss. The Manteno Drainage

District is meeting on August 21<sup>st</sup> to discuss, and the Kankakee County Board will be having a special meeting on August 23<sup>rd</sup> to also discuss. The Manteno School District will meet on August 15<sup>th</sup> to discuss. The hope is that all taxing bodies will approve the resolution and agreement.

• Trustee Martin asked about the water tower at 333 South Spruce. Trustee Martin asked if they could repaint the tower and remove the Kmart logo. Mayor Nugent stated that the water towers are owned by Aqua. The Village is in discussions with Aqua about improvements to the sewer plant. The issue of the water towers will be brought up.

A motion by Trustee Crockett and seconded by Trustee Martin to adjourn the meeting at 7:39 a.m. Voice vote – all ayes.
