MOTION: A motion by McGowan, second by Zimbleman, to waive the reading and approve the meeting minutes of October 12, 2021 as presented with no corrections or deletions. Motion approved 4-0. Dole, Smith and Weiland absent.

Acting Chairman Creek opened the Public Hearing portion of the meeting.

<u>PC-VAR 21-01</u> — The public hearing is to consider a request by Dunkin Donuts (Petitioner) for variances from the Village Ordinance 9-13-14 (D)1, premises signs, number allowed and 9-13-14 (D)4, premises signs, maximum height allowed on the property located at 2803 West Division Street, Manteno in the C-2 Commercial Zoning District.

Eric Carlson with ECA Architects presented the request by Dunkin for the variances to the number of premises signs and the height of a sign that is allowed. Mr. Carlson stated that the request for a higher sign fits with the standard Dunkin prototype. The extra premise sign is due to having two street exposures. One side faces south on Division Street and the other side faces east along Rt. 45/52.

There were no comments from the public. Mr. Marion stated that staff agrees that this is a reasonable request and recommends approval by the commission. There were no questions or comments from the commission members.
