

**ORDINANCE NO. 25-11**

**AN ORDINANCE GRANTING A VARIANCE FROM TITLE 9, ZONING, CHAPTER 7, MULTI-FAMILY RESIDENTIAL DISTRICTS, ARTICLE NUMBER 8(A) MINIMUM LOT AREA, FOR THE PROPERTY LOCATED AT 175 N. McGUIRE DRIVE, MANTENO, ILLINOIS**

WHEREAS, the Village of Manteno is a non-home rule municipality duly created and existing under the laws of the State of Illinois; and,

WHEREAS, an application has been filed by Nathan Donovan DBA Greatest Good, LLC, Petitioner and owner of, real property commonly known as 175 N. McGuire Drive, Manteno, Illinois seeking an 8,481 square foot variance from Manteno Ordinance 9-7D-8(A) minimum lot area requirement; and,

WHEREAS, the Planning Commission held a public hearing on the question of said variance at the Village Board room, on April 02, 2025, at which time all persons desiring to be heard were given the opportunity to be heard; and,

WHEREAS, legal notice of said public hearing was published in the manner and form as required by law; and,

NOW, THEREFORE, be it ordained by the Village President and Board of Trustees of the Village of Manteno, Kankakee County, Illinois, as follows:

**Section 1**

That the Village of Manteno Planning Commission has made its recommendation and findings to approve the request of an 8,871 square foot variance to the required minimum lot size as set forth in Title 9, Zoning, Chapter 7, Multi-Family Residential Districts, Article 8(A).

**Section 2**

That this Board of Trustees has reviewed said recommendation and findings and hereby concurs with Planning Commission Recommendation 24-02 to approve said variance listed in Section 1 herein, on the property legally described as follows:

LOT 2 OF PARKVIEW SUBDIVISION, BEING A PARCEL OF LAND IN THE  
NORTHEAST QUARTER OF SECTION 22, TOWNSHIP 32 NORTH, RANGE 12 EAST  
OF THE THIRD PRINCIPAL MERIDIAN, IN THE VILLAGE OF MANTENO,  
KANKAKEE COUNTY, ILLINOIS
