# **ORDINANCE NO. 25-17**

AN **ORDINANCE** AMENDING TITLE 4, **POLICE** REGULATIONS, **CHAPTER** 1. **MISDEMEANOR** CODE. ARTICLE 6, OFFENSES INVOLVING MORALITY, SECTION 4-1-6-12, GAMBLING, **OF** THE VILLAGE **MANTENO** OF **MUNICIPAL CODE** 

BE IT ORDAINED by the President and Board of Trustees of the Village of Manteno, as follows:

### Section 1

That Title 4 Police Regulations, Chapter 1, Misdemeanor Code, Article 6, Offenses Involving Morality, of the Village of Manteno Municipal Code, be amended by changing Section 4-1-6-12, Gambling, to read as follows:

### 4-1-6-12: **GAMBLING**:

...

(D) Video Gaming Licenses and License Fees. Video gaming licenses shall be valid from May 1 through April 30. No video gaming license shall be issued to an applicant that does not meet the provisions of this section or who has not been issued an applicable license by the Board. The annual business license fee for each licensed establishment, licensed fraternal establishment, licensed veteran's establishment, licensed truck stop establishment in or on which there is located or sited at least one (1) video gaming terminal shall be one thousand dollars (\$1,000.00) per establishment. The annual license fee for the operation of a video gaming terminal shall be two hundred fifty dollars (\$250.00) per terminal. The cost of the video gaming terminal fee shall be shared equally between the licensed terminal operator and the video gaming establishment which owns or operates the video gaming terminal. No refunds or partial refunds shall be given by the village in the event either the licensed terminal operator or video gaming establishment ceases operations. No license fee shall be prorated.

### Section 2

If any section, paragraph, clause, or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

## Section 3

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

# Section 4

This ordinance shall be immediately in full force and effect after passage, approval and publication as provided by law. This ordinance is authorized to be published in pamphlet form.
