

GRANT/RESERVATION OF MUNICIPAL AND PUBLIC UTILITY EASEMENT

VILLAGE OF MANTENO ("Grantor"), hereby grants/reserves unto public utility companies and itself, and their successors and assigns (collectively, "Grantees"), a permanent non-exclusive easement, and for that purpose, the right of access and entry, to place, install, construct, maintain, replace, reconfigure, and operate any and all municipal and public utility infrastructure and appurtenances including, but not limited to, electrical, cable, telephone, gas, water, sanitary, and storm water over, upon, along, under, and through the property legally described in Exhibit "A," and depicted in the plat of easement attached hereto as Exhibit "B" as the "Proposed 25' Public Utility & Drainage Easement" ("P.U.D.E."). No person having or obtaining any interest or right to any portion of the land servient to the P.U.D.E. shall obstruct, build upon, or alter the P.U.D.E. without the express written consent of the Village of Manteno, nor shall any such person interfere with the construction, operation, and maintenance of the municipal and public utilities infrastructure and appurtenances thereon. The Grantees shall have the right and authority to cut down, trim, or remove any trees, shrubs, plants, or other appurtenances on the P.U.D.E. that interfere with the exercise of the rights and authority granted herein. The easement granted herein shall be binding upon and shall inure to the benefits of the heirs, successors, assigns, and licensees of the parties hereto.
