## ORDINANCE NO. 25-27

### AN ORDINANCE AMENDING TITLE 4, POLICE REGULATIONS, CHAPTER 1, MISDEMEANOR CODE, ARTICLE 4, OFFENSES INVOLVING HEALTH, SAFETY AND CHILDREN, BY ADDING SECTION 4-1-4-19, DANGEROUS INTOXICANTS, OF THE MANTENO MUNICIPAL CODE

BE IT ORDAINED by the President and Board of Trustees of the Village of Manteno, as follows:

#### Section 1

That Title 4, Police Regulations, Chapter 1, Misdemeanor Code, Article 4, Offenses Involving Health, Safety and Children, of the Manteno Municipal Code, be amended by adding Section 4-1-4-19, Dangerous Intoxicants, as follows:

#### 4-1-4-19: **DANGEROUS INTOXICANTS:**

(A) Definitions: For the purposes of this section, the following definitions shall apply unless the context clearly indicates or requires a different meaning:

*Kratom Product* means any product containing, being advertised as, or functioning similarly to the plant *Mitragyna speciosa*, whether natural, synthetic, or a semi-synthetic, and irrespective of the quantity of any natural or synthetic material, compound, mixture, preparation, substance and their analog (including isomers, esters, ethers, salts, and salts of isomers) of that plant, or any derivative thereof.

*Synthetic Cannabis Product* means product containing a laboratory-created compound functioning similarly to cannabis or a cannabinoid including, but not limited to cannabigerolic acid (CBGA), cannabidiolic acid (CDBA), cannabichromenic acid (CBCA), Tetrahydrocannabinolic acid (THCA), cannabichromene (CBC), cannabidiol (CBD), cannabinol (CBN), cannabigerol (CBG), Tetrahydrocannabinol (THC), Hexahydrocannabinol (HHC), whether natural, synthetic, or a semi-synthetic, and irrespective of the quantity of any natural, synthetic, or semi-synthetic material, compound, mixture, preparation, substance and their analog (including isomers, esters, ethers, salts, and salts of isomers) containing a cannabinoid receptor agonist, or any derivative thereof.

*Synthetic Psychedelic/Hallucinogen Product* means any product containing a laboratory-created compound functioning similarly to any US DEA Schedule I psychedelic/hallucinogenic drug, whether natural, synthetic, or a semi-synthetic, and irrespective of the quantity of any natural, synthetic, or semi-synthetic material, compound, mixture, preparation, substance and their analog (including isomers, esters, ethers, salts, and salts of isomers), or any derivative thereof, which has a psychedelic/hallucinogenic effect on the central nervous system and/or brain.

*Synthetic Opioid Product* means any product containing a laboratory-created compound functioning similarly to the plant *Papaver somniferum*, whether natural, synthetic, or a semi-synthetic, and irrespective of the quantity of any natural, synthetic, or semi-synthetic material, compound, mixture, preparation, substance and their analog (including isomers, esters, ethers, salts, and salts of isomers) of that plant, or any derivative thereof, which has a euphoric or morphine-like effect on the central nervous system, brain, and/or gastrointestinal system.

*Synthetic Stimulant Product* means any product containing a laboratory-created compound functioning similarly to any US DEA Schedule I stimulant, whether natural, synthetic, or a semi-synthetic, and irrespective of the quantity of any natural, synthetic, or semi-synthetic material, compound, mixture, preparation, substance and their analog (including isomers, esters, ethers, salts, and salts of isomers), or any derivative thereof, which has a stimulating effect on the central nervous system and/or brain.

(B) Sale, Delivery, Display, Purchase, and/or Possession Prohibited. It is hereby declared unlawful and a public nuisance for any person to sell, deliver, display, and/or possess any Kratom Product, Synthetic Cannabis Product, Synthetic Psychedelic/Hallucinogen Product, Synthetic Opioid Product, and/or Synthetic Stimulant Product in the Village of Manteno.

(C) Penalties and Administration.

- (i) Any person found in violation of the provisions of this section shall be fined not less than two hundred fifty dollars, (\$250) not more than seven hundred fifty dollars, (\$750) for each offense. Each day a violation continues shall constitute a separate and distinct offense. To the extent applicable, business licensees shall be responsible for the violations of this Section by their employees and agents.
- (ii) Any business licensee found in violation of the provisions of this section shall, in addition to any fine that may be imposed, be subject to business license suspension and/or revocation proceedings.
- (iii) Violations of this section may be administered in accordance with the provisions of Title 1, Administrative, Chapter 17, Administrative Adjudication, of the Manteno Municipal Code.

## **Section 2**

If any section, paragraph, clause, or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

#### Section 4

This ordinance shall be immediately in full force and effect after passage, approval and publication as provided by law. This ordinance is authorized to be published in pamphlet form.
