Vince gave an update on a pending lawsuit regarding the pension fund transition in Kane County, a ruling hasn't been made from a case heard back in Feb '22. He also indicated there was legislation presented regarding the funds transfer and that it never made it to a vote in legislation session. Legislative session is now closed. As of 4/1/22 Vince indicated that only around 10% of Police Pension funds have been transferred to the State. He also indicated that we are waiting on a date from the consolidated board for a new fund transfer date. He also mentioned that his clients that have already transferred funds to the State have been able to smoothly withdraw needed funds when requested. Vince asked if the Manteno PPB has our cash management and authorized agents established and we established both at our 1st Qtr meeting.

Treasurers Report - Sheila Martin presented the Treasurers Report by providing a summary of bills and the checking account balance which are attached to the minutes. The checking account balance was \$151,083.82 as of 04/21/2022. The Police Pension acct received a final contribution from the Village of Manteno of \$97,152. The portfolio began the quarter at \$11,038,063 and ended the quarter at \$10,588,021. There was a total \$ change this quarter of \$(450,052) with a 1st Qtr total fund return of -4.1%. Some market highlights from the packet were U.S. inflation reached 7.9%, consumer prices are the highest in 40 years, Fed raised interest rates for the first time since 2018, gas prices shot up at the fastest rate on record.
