1) ORDINANCE 20-12: (Mayor Nugent)

An Ordinance amending Title 3, Business Regulations, Chapter 9, Liquor, by changing Section 3-9-3, Applications, Section 3-9-6, Bond, and Section 3-9-15, Transfer, of the Municipal Code for the Village of Manteno.

As discussed at the finance committee meeting, the process for obtaining a liquor license from an existing business was somewhat cumbersome. This revision allows for a simpler transfer to make the process easier for staff and for the applicant. Additionally, there was some language and requirements in the previous ordinance that were no longer necessary. This updates the ordinance to reflect the current process.

2) ORDINANCE 20-13: (Trustee Crockett)

An Ordinance granting a Variance from Title 9, Zoning, Chapter 7, Residential Districts, Article Number B-8(D)3, Rear Yard Setback for the property located at 143 West Sixth Street, Manteno, IL in the R-1 Residential Zoning District.

On September 9th, the Plan Commission held a public hearing to determine if a variance should be allowed to facilitate a garage addition for the property located at 143 W. Sixth Street. As discussed at that meeting, this is a unique property with street frontages on three sides. In this case, the circumstances warrant the requested variance and the Plan Commission is recommending approval by the Board.

3) CONSIDERATION RE: (Trustee Gesky)

❖ A motion to approve the payment of \$30,000.00.to Curwick II LLC in reference to a TIF Façade Agreement approved May 6, 2019.

Developer Jerry Curwick was approved for a façade renovation grant for the building located at 51 N. Main Street. The work has been completed and all required documents have been received to facilitate the reimbursement payment.

4) ORDINANCE 20-14: (Trustee Phillips)

❖ An Ordinance amending Title 3, Business Regulations, Chapter 7, Itinerant Merchants, Article 4, License Fee, by changing Section 3-7-4 of the Municipal Code for the Village of Manteno.

This ordinance was discussed at a committee meeting after staff review found the fees had not been revised for an extended period of time. The Board agreed the for-profit fee should be raised from \$10 per day to \$50. Non-profit fees will remain at \$10 per day. This ordinance will take effect at the beginning of the fiscal year in 2021.

ORDINANCE NO. 20-12

AN ORDINANCE AMENDING TITLE 3, BUSINESS REGULATIONS, CHAPTER 9, LIQUOR, BY CHANGING SECTION 3-9-3, APPLICATIONS, SECTION 3-9-6, BOND, AND SECTION 3-9-15, TRANSFER, OF THE MUNICIPAL CODE FOR THE VILLAGE OF MANTENO

BE IT ORDAINED by the President and Board of Trustees of the Village of Manteno, Kankakee County, Illinois, as follows:

Section 1

That Title 3, Business Regulations, Chapter 9, Liquor, of the Municipal Code for the Village of Manteno, be amended by changing Section 3-9-3, Applications, to read as follows:

3-9-3: **APPLICATIONS**: An application for a village retailer's license for the sale of alcoholic liquor shall be made in conformity with the general requirements of this code relating to applications for licenses. When the applicant is not the owner of the premises, the application shall be accompanied by a valid lease between the owner and applicant for a minimum of one year to coincide with the period for which the application is made. The requirements for lease shall not apply in the event that the applicant is the manager of the business and the applicant and the business meet all other requirements of this chapter. Such applications shall be made in writing to the village clerk, who upon receiving the same, shall forward and deliver to the president of the board of trustees such application for license and the said president of the board of trustees, as the local liquor control commissioner shall thereafter take such action as he may see fit to take pursuant to law. When the application for license is so presented to the president of the board of trustees stating the name of the applicant, the resident address of the applicant, and the street number and location of the premises covered by the application, said application may then be referred by the president of the board of trustees, either to the board of trustees as a whole in lawful meeting duly assembled, or to a duly appointed committee composed of duly elected members of the board of trustees as a whole or by the committee thereof to which said application may be referred, and said board of trustees or committee shall thereupon in a regular meeting duly assembled make such recommendations to the president of the board of trustees as shall be deemed best in their or its judgment. No license shall be issued hereunder until such application has been considered as herein provided, and then only when the president of the board of trustees, acting as the local liquor control commissioner, shall approve such application in writing.

Section 2

That Title 3, Business Regulations, Chapter 9, Liquor, Section 3-9-6, Bond, of the Municipal Code for the Village of Manteno, is hereby repealed.



Section 3

That Title 3, Business Regulations, Chapter 9, Liquor, of the Municipal Code for the Village of Manteno, be amended by changing Section 3-9-15, Transfer, to read as follows:

3-9-15: **TRANSFER:**

- (A) The local liquor control commissioner, with the consent of the Board of Trustees, may permit the transfer of interest in or to a license issued for the sale of alcoholic liquors at retail at any location to which said license has been issued upon: (1) the filing of a new application (along with the manager's application and valid lease, if applicable) a minimum of four (4) weeks prior to operations under the transferred license is anticipated to commence; and (2) the payment of a transfer fee corresponding to the applicable license fee at the time the application is filed with the Village Clerk. No such transfer shall be permitted if the existing license is suspended or revoked, or if any fees remain outstanding for the original license or licensee. Upon approval, a new liquor license will be issued effective no sooner than the later of the return of the original village-issued license certificate and the date the original license is deemed surrendered as identified in a letter of recission signed by the original licensee. For the purpose of this section, a transfer of any interest in a company, partnership, association, or of five (5%) percent or more of ownership in shares of the stock of a corporation, shall be transfer of interest and require the payment of the transfer fee provided for by this subsection. In the event the transfer is requested within six (6) months of a license renewal date (i.e., November 1 – April 30 of a license year) then the fee shall be fifty (50%) percent of the applicable transfer fee.
- (B) Except as authorized in subsection (a) above, it shall be unlawful for any licensee to transfer or to attempt to transfer, either directly or indirectly, any license for the sale of alcoholic liquor. issued pursuant to the provisions of this chapter are not subject to sale, assignment, transfer or to a change of location.

Section 4

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

Section 5

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

Section 6

This ordinance shall be immediately in full force and effect after the passage and approval as provided by law.

AN ORDINANCE GRANTING A VARIANCE FROM TITLE 9, ZONING, CHAPTER 7, RESIDENTIAL DISTRICTS, ARTICLE NUMBER B-8D(3), REAR YARD SETBACKS FOR THE PROPERTY LOCATED AT 143 WEST SIXTH STREET, MANTENO, IL IN THE R-1 RESIDENTIAL ZONING DISTRICT.

WHEREAS, the Village of Manteno is a non-home rule municipality duly created and existing under the laws of the State of Illinois; and,

WHEREAS, an application has been filed by Chris LaMore, owner of the real property commonly known as 143 West Sixth Street, Manteno, Illinois, with the Planning Commission of the Village of Manteno, Kankakee County, Illinois, seeking a variance from Manteno Ordinance 9-7B-8(D)3 in the R-1 Zoning District by allowing a variance to the rear yard setback; and,

WHEREAS, the Planning Commission held a public hearing on the question of said variance at the Village Board room, on September 9th, 2020, at which time all persons desiring to be heard were given the opportunity to be heard; and,

WHEREAS, legal notice of said public hearing was published in the manner and form as required by law; and,

NOW, THEREFORE, be it ordained by the Village President and Board of Trustees of the Village of Manteno, Kankakee County, Illinois, as follows:

Section 1

That the Village of Manteno Planning Commission has made its findings of fact and recommendation to approve the request to allow for an twelve (12) foot variance as set forth in Title 9, Zoning, Chapter 7, Residential Districts, Article Number, B-8(D)3, Rear Yard Setback.

Section 2

That this Board of Trustees has reviewed said findings of fact and recommendation and hereby concurs with Planning Commission Recommendation 20-08 to approve said variances listed in Section 1 herein, on the property legally described as follows:

A RECOMMENDATION APPROVING A 12'FT VARIANCE FROM TITLE 9, ZONING, CHAPTER 7, R-1 SINGLE FAMILY, ARTICLE NUMBER 9-(7) (B)8, YARDS (D)3, REAR YARD SETBACK, FOR THE PROPERTY LOCATED AT 143 W SIXTH STREET MANTENO, IL 60950 IN THE R-1 RESIDENTIAL ZONING DISTRICT.

ORDINANCE NO. 20-14

AN ORDINANCE AMENDING TITLE 3, BUSINESS REGULATIONS, CHAPTER 7, ITINERANT MERCHANTS, ARTICLE 4, LICENSE FEE, BY CHANGING SECTION 3-7-4, OF THE MUNICIPAL CODE FOR THE VILLAGE OF MANTENO.

WHEREAS, the Village of Manteno is a non-home rule municipality duly existing and subject to the laws of the State of Illinois; and,

WHEREAS, Section 3-7-4 of the Manteno Municipal Code sets forth requirements for the fees to be charged for itinerant merchants; and,

WHEREAS, the Village of Manteno deems it necessary, desirable and in its best interests to amend §3-7-4; of the Manteno Municipal Code, to update the fees to be charged to allow itinerant merchants; and,

NOW, THEREFORE, BE IT ORDAINED by the Village President and Board of Trustees of the Village of Manteno, Kankakee County, Illinois, as follows:

Section 1

The recitals set forth in the above prefatory clauses are hereby adopted as the findings of the Village of Manteno and are expressly incorporated herein as a part of this ordinance.

Section 2

That Title 3, Business Regulations, Chapter 7, Itinerant Merchants, Article 4, License Fees, be changed by amending Section 3-7-4, to read as follows:

3-7-4: LICENSE FEE:

The fees for an itinerant merchant's license shall be based on the number of days for which such license shall be issued and shall be at the rate of ten dollars (\$10.00) per day for any non-profit 501C merchant. The daily fee for all other merchants shall be fifty dollars (\$50.00) per day.

Section 3

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

Section 4

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

Section 5

This ordinance shall take effect on May 1, 2021 after passage, approval and publication. This ordinance is authorized to be published in pamphlet form.
