- 1. Planning Commission Recommendation 19-06 on the requested special use permit by Peoples Bank of Kankakee County. Peoples Bank of Kankakee County (Owner) is requesting the required Special Use Permit to install a three (4) lane drive-thru and external ATM for the use of its banking customers. The new branch bank is being constructed next to the old Family Video building located at 198 South Creek Dr. Current ordinance requires a special use permit for any and all drive-in or drive thru. After conducting the public hearing on the special use permit requested, the Planning Commission will be asked to make a recommendation to the Village Board.
